Position Summary: The St. Joseph Gift & Thrift Associate helps the full-time manager in overseeing the operations of the St. Joseph Gift and Thrift store by providing staff, volunteers, donors, and customers with a dignified and positive experience. The Associate also assists in supervising the overall wellness of staff and the incorporation of volunteers into donation processing while maintaining a clean, organized, and well-curated storefront.

Essential Functions:

- Assist with store operations and volunteers during assigned shifts, including customer service, merchandising, sorting, stocking and staging inventory, and display maintenance.
- Supervise and train volunteers.
- Welcome clients, customers, volunteers, donors, and vendors.
- Answer the phone in a kind, appropriate manner.
- Coordinate and stage donated items to create a welcoming environment for customers.
- Ensure stockrooms are maintained in a neat and organized manner to facilitate moving to the retail floor and ensure safety of others always.
- Assist with customer checkout as needed.
- Oversee gift card redemptions with clients.
- Manage internal controls of cash and inventory.
- Support activities that serve the objectives of the CSS Sustainability Team.
- Adhere to the personnel practices of Catholic Social Services and participate in the annual Diocesan Safe Environment Training.
- All other duties as assigned.
- Represent, communicate, and integrate authentic Catholic social teaching in the presentation of CSS' mission.
