**Position Summary:** The Truck Driver and Warehouse Support Specialist in Lincoln oversees the day-to-day operations of donor pickups and client deliveries and supports the Lincoln warehouse. This individual provides support to program staff and agency recycling efforts.

#### **Essential Functions:**

- Perform daily maintenance including oil checks on fleet vehicles used.
- Perform deliveries and pickups of household goods and furniture as scheduled with focus on client needs and donor appreciation.
- Assist program staff in the delivery of services, including food market and event set-up.
- Transport and set up household materials following the move-out of St. Gianna residents.
- Assist in warehouse inventory functions and tracking of warehouse production.
- Assist thrift-stores managers with special projects and deliveries of items between warehouses.
- Assist with snow removal.
- Assist with recycling and processing of donations at the warehouse.
- Adheres to all safety precautions in the driving of fleet vehicles and the handling of furniture and household items.
- All other duties as assigned.
